- **1. Introduction:** Child Rights Week is celebrated every year around the world. The main objective of this week is to raise awareness about Child Rights and bring a positive attitude towards them in society. Various programmes, activities and awareness campaigns are organised to convey this message. In 2023, the week started on the 14<sup>th</sup> of November and lasted until the 20<sup>th</sup> of November. As children in tribal areas lack awareness of their rights, they can be easily deprived of these. Child Rights are essential for human society. It is important for the children of the tribal community to ensure their safety and take care of their education, health, and nutrition.
- 2. Objective of Child Rights Week: In this series, every year through Child Rights Week, Vaagdhara enhances social dialogue on this crucial subject within its operational area. It inspires communities and various stakeholders to recognise children's equal rights. This is to motivate many children in tribal communities who are deprived of their rights and face various issues such as educational inequality, child labour and the malpractice of child marriage. Addressing these issues and ensuring rights are crucial. The organisation plays a significant role in creating a child-friendly environment and building awareness in villages. Keeping this objective in mind, activities were organized in 1041 villages of Tribal Tri-Junction of Rajasthan, Madhya Pradesh & Gujarat states.
- **3. Procedure of Child Rights Week Celebration:** Meetings with moderators were organized for Child Rights Week. The mediators were responsible for communicating the activities that took place during the week. Further, children's rights, the right to life, the right to development, the right to protection, and the right to participation were



discussed so that the moderators could thoroughly educate the children and the community. In addition, the facilitators were instructed to inform the members of all groups and organizations at the village level about the celebration one day in advance and documents on Children's Rights Week were explained and distributed to everyone.

- **4. Main Activities:** The primary activities carried out with the children during Child Rights Week are as follows. Local poetry, games, music, a Child Rights Awareness Rally, Antakshari, Sitolia, Hide and Seek, Kabaddi, Rope Pulling, 100 meters race, High Jump, Long Jump, discussions on village-level issues, unemployment, migration, farming, education, and dialogues on issues such as government schemes, awareness about foster care, scholarships, free education, mid-day meals, the Chief Minister Raj Shree scheme, and issues related to True Farming were organized at the village level in collaboration with Gram Swaraj Group, Bal Swaraj Group, Saksham Group and Agriculture and Tribal Swaraj Organization.
- 5. Main discussion topics: During the program, children were made aware of Child Rights and how problems such as nutrition and health can be solved at local level through community efforts. The members of the Gram Swaraj Group explained that in addition to Child Rights, their health is also important. As far as nutrition is concerned, nutrition bars should be placed in every house so that children get nutritious fruits and vegetables, which can improve children's health and nutrition. In addition, parents were made aware of the family's responsibility towards their children and the activities related to children's development at the Anganwadi level so that attention can be paid to children's development at home as well. At the same time, they were made aware of the benefits of allowing children to participate in the family as it provides them with a platform to acquire skills such as speaking, self-confidence and open expression from the very beginning.

**8. Request letter preparation and its use:** All issues were discussed jointly by the members of Gram Swaraj, the Bal Swaraj Group, and the Saksham Group. They also collectively debated how to resolve the issues at the village and government level. After considering all the points, a proposal letter was prepared on the basis of the issues at the government, village, gram panchayat, panchayat samiti and district level.

After preparing the proposal letter, the responsibilities for the presentation were defined at different levels by the members of the Bal Swaraj Group, the Gram Swaraj Group, the Saksham Group and the Agriculture and Tribal Swaraj Organisation.

The Bal Swaraj Group took responsibility at



the village level. In addition, the members of the Gram Swaraj Group and the Saksham Group took the responsibility of submitting the application at the Gram Panchayat level. Moreover, the Agriculture and Tribal Swaraj Organisation took the responsibility to present it at the Gram Panchayat and District level. As elections are coming up in Rajasthan and Madhya Pradesh, all the members of the Gram Swaraj group took the responsibility of presenting the petition letters to the candidates of all the parties with the aim of making the government aware of the problems and resolving them soon.

- **9. Role of Bal Swaraj Group:** All members of the Bal Swaraj Group played a significant role in this program. They informed all the organizations and parents in the village a day in advance so that more community members could participate in the Child Rights Week activities. This was to ensure that a larger number of parents could understand the importance of Child Rights and support the children in obtaining their rights. All the children made the community aware of issues related to children and presented various presentations through various programs.
- 10. Role of the Gram Swaraj Group and the Saksham Group: During Child Rights Week, members of the Gram Swaraj Group and the Saksham Group actively participated and fulfilled their roles. Members of the Gram Swaraj Group and the Saksham Group raised awareness about education among children and the community. They also made the community aware of children's rights. Additionally, all members discussed and planned solutions for emerging issues, ensuring a quick resolution at both the village and government levels. This was aimed at addressing issues for the benefit of the children. The members cooperated in preparing plans and drawing attention to government issues. They prepared proposals on the issues and sent them to the village panchayat and members of the agriculture and tribal Swaraj organization for prompt action on these matters.

**11. Role of Agriculture and Tribal Swaraj Organization:** Members of Role Agriculture and Adivasi Swaraj Sangathan participated in the Child Rights Week activities and discussed the current education situation and issues at KASS level. To



the children, the benefits of their rights were explained so that they can realize them in their lives. Members of the Agriculture and Tribal Swaraj Sangathan Group talked about tehsil-level issues and decided that these issues should be taken to tehsil and district level. The group has taken the responsibility to ensure that the issues arising from this

Child Rights Week are taken forward soon so that the attention of the government and local administration can be focused on rural development and child development. In addition, the group took the responsibility to send advance letters to the current candidates of the local legislative assembly.

**12. Key Learnings of the Program:** The main lesson from this program is that during Child Rights Week, children were provided with a platform at the village level to express their views on their issues. They realized how essential rights are for children, which can be exercised by all children from 0 to 18 years of age. A shared understanding was formed on these rights, encompassing the right to live, develop,

protect, and participate in life. Currently, there is a serious need for dialogue on issues such as education and health, and everyone's understanding is aligned on these pressing matters. The program aimed at ensuring that children can connect with their traditional culture, which is gradually fading away. Children learned to differentiate between village-level and

# बाल अधिकार सप्ताह का आयोजन

खांसवाड़ा। विश्व वाल अधिकार सप्ताह के तहत वाण्यारा संस्था की ओर से राजस्थान, मध्यप्रदेश एवं गुजरात के 1041 गांवों में बाल अधिकार प्रपाद गतिविधियों का आयोजन किया जा रहा है। यह सप्ताह 14 से 20 नवंबर तक मनाया जाता है। इस दौरान बाल अधिकारों के संदर्भ में चर्चा करते हुए उन्हें उनके अधिकार, जीवन जीने, विकास, तर्में का अधिकारों के मुन्न मुंक्यांकन के लिये है। बाल अधिकारों के पूर्व मुख्यांकन के लिये

government-level issues so that in the future, they can work on these issues. They also gained the ability to contribute to the resolution of issues at the village level. Through dialogue with the organization, children learned at which levels issues can be addressed. The Children's Rights Week helped children understand and apply various

skills, including decision-making, self-confidence, communication, creative and critical thinking, and presentation skills. This led to the development of skills in children during this week.

### 13. Problems during the Event:

- As Child Rights Day took place right after Diwali, the attendance of children was lower than usual as many were away for family visits.
- Low attendance of parishioners due to the elections.
- The municipality was unable to devote much time due to agricultural work.
- Due to the Mansa Vrat Puja on the 20th, there were fewer children present.

### 14. Improvement Suggestions:

- Bal Swaraj Group meetings should be held regularly every month at the community level.
- There should be regular discussions on children's rights during the meetings of the Bal Swaraj Group.
- The community should be included in the meetings of the Bal Swaraj Group.
- Regular follow-up should be done on the issues that arise to ensure that solutions are identified for these issues.
- Discuss the issues of Child Rights Week in regular meetings of Gram Swaraj
  - Group, Saksham Group, and Agricultural and Tribal Swaraj Organization so that steps can be taken towards solutions.
- The community facilitator should engage in a dialogue during community-level meetings on the issues that arise during Child Rights Week.



### 15. Responsibilities and Follow-up Plan:

1	Gram Swaraj Group Members	All members of the Gram Swaraj Group will jointly follow up on the issues at the Gram Panchayat level. The President of the Gram Swaraj Group will be given information on what action is being taken on the issue. The Secretary will regularly meet with the Village Development Officer so that everyone is aware of the situation.
2	Bal Swaraj Group Members	All members of the Bal Swaraj Group will jointly follow up on education-related issues at the community level and share the progress with the community facilitator. We will also share the progress report on the demand letter with the Gram Swaraj Group.
3	Saksham Group Members	The women of the Saksham group will work on village and school-level issues and also inform the members of Gram Swaraj and Bal Swaraj groups about their progress. They will engage with the Ward Panch on regular village-level issues.
4	Agriculture and Tribal Swaraj Organisation Members	The group will take the initiative on panchayat and district-level issues. It will also share the progress of the issues with the staff of the organisation. In addition, they will work continuously to resolve the issues and will have the primary responsibility in doing so.

16. **News Coverage:** To bring the message and activities of Child Rights Week 2023 to a wider audience, information was shared via newspaper articles and social media platforms. On the one hand, the objectives and aspects of child

rights were explained once again, and on the other, the practical implementation of the day was described. This included mentioning the Vaaqdhara well experts as as the moderators and teachers involved organizing the day by name and sharing their expertise. The articles emphasized the right to play and a pleasant living environment as they are crucial for proper child development.
